English Proficiency Requirement

- A minimum score of Band 3 in MUET, 5.0 in IELTS or 47 in PTE Academic or its equivalent, or
- Grade A in the English Language subject at SPM/UEC level

LOCATION MAP

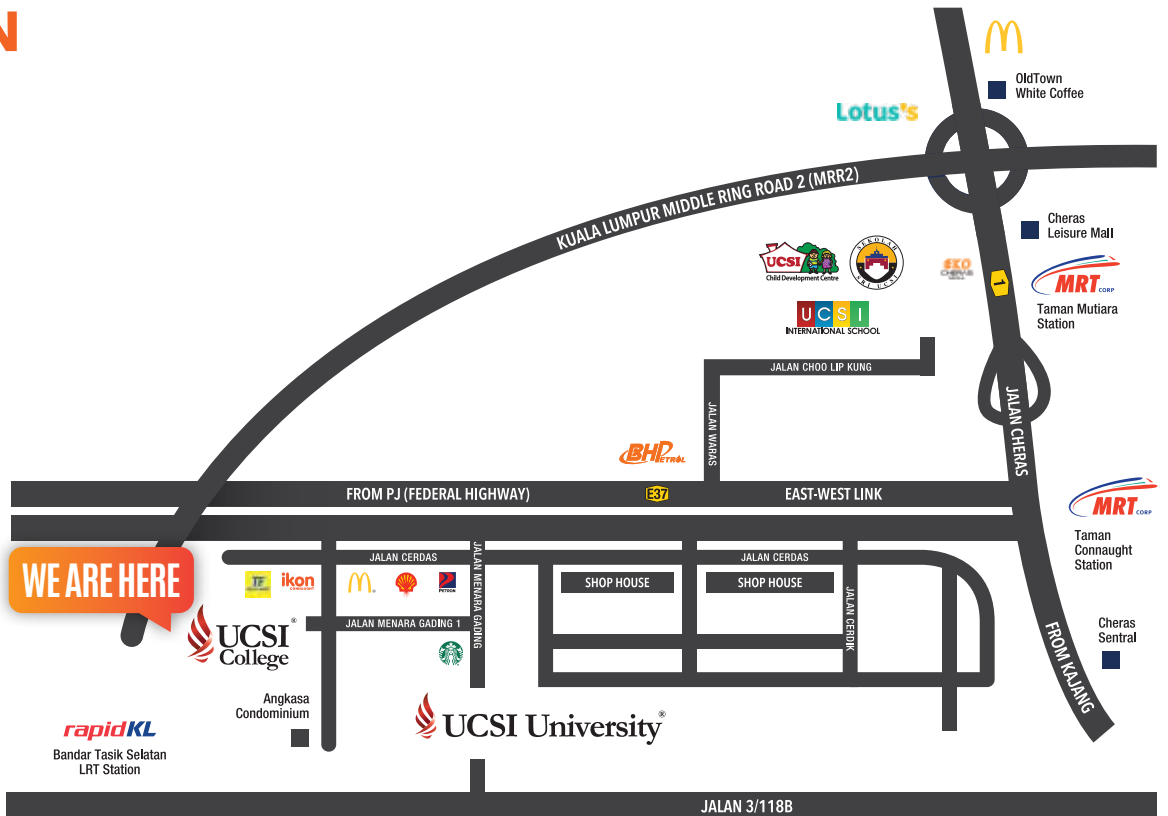
